

# A Guide to 2024, Capitol Hill Edition

ast month I looked ahead at 2024 from a regulator's perspective—what can defense credit unions expect from NCUA and CFPB? This month I am going to lay out (guess) what Capitol Hill is going to do on credit unions, and what that will mean for your credit union.

Here are some issues that could be on the Congressional menu in 2024:

**Credit Card Competition Act:** the so-called "Durbin Amendment" would create price controls on credit card transactions by allowing retailers to use cheaper, less reliable, and less-secure payment rails. It would build on the unworkable Durbin debit caps from 2010, and Senators Richard Durbin (D-IL) and Roger Marshall (R-KS) have introduced legislation to achieve that dubious goal.

That's the bad news. The good news is that this bad bill appears to have stalled, at least in part because credit unions have told Congress in no uncertain terms that the Durbin bill is NOT pro-consumer, it would degrade data security and privacy.

Merchants continue to press their case—Senator Durbin says he'll hold a hearing on the issue as a way to inject new life into the moribund bill—but for now the CCCA appears stalled. Continuing vigilance by credit unions will keep things going in the right direction here. **Tax bill:** The House Ways and Means Committee passed a tax reform package in January that would extend expiring business tax breaks for business and expand a child tax credit. To the surprise of almost everyone, House Ways and Means Chairman Jason Smith (R-MO) and his Democratic Senate counterpart Ron Wyden (D-OR) agreed on the package before it was introduced. And according to Committee staff involved in the drafting, the credit union tax exemption was never once been discussed by the tax writers during this process.

The House passed the bill 357-70, and the Senate may take it up later this spring. Bottom line: the credit union tax exemption is not part of the conversation continued vigilance will keep it that way.

**Cannabis banking:** For the 7th consecutive Congress, a bill allowing credit unions to serve marijuana businesses is in limbo. The Senate Banking Committee approved a bill modeled after a House-passed version... and it promptly ran into trouble when a group of Senators insisted on cannabis decriminalization and other changes.

What breaks the logjam? A legislative solution may not be possible (even though decriminalization advocates signaled they MAY be open to dropping some demands). But it's rumored that the Biden Administration could re-classify cannabis as a lessdangerous drug, opening the door to more lenient legal treatment. Maybe shortly before the November election?

**Credit union modernization:** A bill was re-introduced to give NCUA authority to examine CUSOs and other credit union vendors. This promises to be controversial—credit unions have never been comfortable with giving the regulator such broad new powers.

Sweeteners may be added to gain support, such as tweaks to the Federal Credit Union Act to modernize board meeting requirements, extend loan maturities and upgrade the Central Liquidity Facility (which would give credit unions improved access in case of a crisis).

These ideas, whether taken individually or as a package, could be something credit unions can get to work on as the year develops.


On the horizon?: Watch for possible hearings in both the House and Senate financial committees on alleged lending discrimination (made in a CNN televised report in December) regarding Navy Federal Credit Union. ■

"Our biggest asset is our people, and it's becoming more and more prevalent that we're exposed to more and more toxins every day, so early detection of any type of cancer is huge towards survival," said Waltham Fire Chief Randy Mullin.

"This initiative is incredibly important, and we are excited to see the impact this effort will make for first responders in New England. We are grateful to Service Credit Union for their dedication to the health and safety of firefighters," said Brian Ryll, president of the Professional Firefighters of NH.

AFFCU holds an underserved charter designation for a five-state region including Texas, Oklahoma, Arkansas, Louisiana, and Mississippi.

The Board of Directors and Management of AFFCU plan to share the new name and logo with the membership of the credit union and with the public in March 2024. The name change will take effect April 2, 2024.

#### SAFE FCU Members Get Over \$1 Million from Giveback Program

#### The PenFed Foundation Partners With Canine Companions to Help More Veterans Get Lifechanging Service Dogs

### National campaign addresses urgent need for more volunteer puppy raisers

The PenFed Foundation announces a groundbreaking partnership with Canine Companions to help provide more service dogs to veterans and others with a disability. The nationwide campaign is focused on recruiting more volunteer puppy raisers and encouraging more corporations to allow their employees to raise service dogs in the workplace. Canine Companions' Pilot, a 10-week-old yellow Labrador/Golden Retriever cross, is the face of the new initiative. He's being raised by PenFed Foundation President Andrea McCarren, her sixth future service dog in training.

"I've witnessed firsthand the extraordinary healing power of service dogs," said McCarren. "Service dogs save lives and there's never been a greater demand. The PenFed Foundation felt compelled to partner with Canine Companions to address the urgent need for more volunteers to raise puppies and help shorten the wait time for those in need. We also want to highlight the transformative, positive impact on a workplace when an employee raises a service dog."

Canine Companions is the nation's premier service dog organization. Founded in 1975, it has already placed more than 8,000 dogs. The organization provides these highly trained service dogs free of charge, but the current wait time to receive one of these dogs can be up to two years.

"Canine Companions is grateful to The PenFed Foundation for this important initiative to increase awareness regarding the need for volunteers across the country to raise future service dogs," said Canine Companions CEO Paige Mazzoni. "Our expertly trained service dogs begin their journey with volunteers before attending professional training at one of our seven locations. This initiative will help expand our community of support and ultimately help us achieve our goals to create more independence for our injured military veterans, other adults and children with disabilities."

PenFed CU President/CEO James Schenck introduced the Canine Companions puppy raising program to his employees in 2018. Since then, he's supported his employees raising nine service dogs at PenFed financial centers across the country.

"Having puppies with such a life changing mission in the workplace builds a culture of kindness and respect. It increases morale, lowers blood pressure and encourages employees to work from the office," said Schenck. "It's a wonderful way to give back to those who served and have employees work together to accomplish a meaningful goal."

Service dogs can only be raised and trained one at a time, and their journey begins with dedicated volunteer puppy raisers. These volunteers play a crucial role socializing the pups from eight weeks of age until 18 months, when they return to Canine Companions for professional training. 
